## **President's Report**

#### Jean Woeller

- · BRFM has 300 members and represents 100 riverfront properties affected by the project
- Active participation with Calgary River Communities Action Group (CRCAG) as a member of the Bow Committee advocating for upstream flood mitigation
- Continued participation in the Bowness Community Flood Mitigation Working Group with City of Calgary and the BCA
- Collaborating with John Larsen from Edelman for PR and strategy support & to a lesser extent Michael Marion, Borden Ladner Gervais LLP for legal support
- COVID restrictions have impacted our fundraising ability and use of traditional methods for outreach; however we've been successful with...
  - the #SLOWTHEBOW lawn sign campaign and resulting media attention
  - · a river residents meeting in July 2020 outside, with physical distancing and informative
  - · pushing the City to study the feasibility and delay preliminary & detailed design phases of the project

## **President's Report**

- City of Calgary senior leadership has made promises and later reneged
- BRFM responded recently with letter to City Manager from our legal counsel, escalating our concerns and re-iterated our request for groundwater field data

The reality is that the proposed Project will have a direct and immediate impact on the members of BRFM, and on their lands. This level of impact mandates a high degree of openness, transparency, and fairness in the process. BRFM seeks meaningful engagement, meaningful information, and meaningful consideration of its concerns. To date, this has simply not happened.

We look forward to a positive response from you at your earliest opportunity, as BRFM's requests for information and engagement with Advisian have been outstanding for months. Without this information, BRFM and the landowners it represents, are being denied critical information necessary to allow their own experts to assess and provide input into the Project process. This cannot possibly be what The City has intended to be meaningful engagement on such an impactful Project.

## **President's Report**

- BRFM continues to assert that we must keep the water OUT of the City through effective upstream mitigation
- The barrier project schedule continues to slip (a blessing and a curse)
- As this project drags on we need your continued financial support so that we can continue to be your advocate with the City and the Province

## **Bowness Community Flood Mitigation Working Group**

#### **David Burton**

- BRFM has been directed to engage with The City through the working group that was formed in 2019 by The City of Calgary with support from the Bowness Community Association (BCA)
  - Members include flooded and non-flooded residents and business, the BCA, BRFM and the Ward 1 councillor's office, along with an outside facilitator
- Acts as an engagement liaison between The City's Barrier Project team and Bowness residents, providing resident-specific feedback on the project's impact, technical studies, feasibility, and engagement
- Meetings every 2 weeks, with several key studies, including Stormwater Management, Hydrotechnical, Groundwater Flow Modelling & Simulation reports, presented and reviewed
- Extensive analysis and technical feedback has been provided by BRFM as to how Bowness residents
  might be affected by both overland and/or groundwater flooding despite the barrier
- The Working Group also provides feedback on engagement plans for the community and equitable treatment for all Bowness residents compared to other river communities where flood mitigation measures are already underway


- Technical studies have been presented to the Community Working Group:
  - Environmental Base Line Assessment (presentation & report)
  - Hydrology Report (presentation & report); finding that barrier overtops at 1425 m3/sec not 1550 m3/sec
  - Stormwater Study (presentation only; waiting on report)
  - Groundwater Study (presentation only; waiting on report)
  - Flood Damage Cost Model (presentation only; there may not be a report issued)

## **Technical Committee - Groundwater Study**


Without gw mitigation there may be significant gw flooding

 A new model shows little gw rise to surface unlike the AE report; using low horizontal conductivity

 A presentation showed modeled gw at Burton and Greiner properties confirming berm results in no material reduction in basement flooding



lodd's home gw will rise to river level with or without barrier. Ground level is higher because of backfill




- 8 barrier options with gw protection were modeled & can be assumed to be expensive and intrusive
- City has not decided which options will be evaluated in Triple Bottom Line analysis
- BRFM needs an official report & study data for Dr Dabrowski to provide a professional review

## **Technical Committee - AEP BRRO Phase 1 Evaluation**

- Province evaluated 3 river reaches: Glenbow East, Ghost Dam expansion, upstream of Morley
- · Morley has the largest volume
- Objective of the reservoir is to reduce peak flow rate in Calgary to < 1200 m3/s, without consideration of gw flooding in Calgary
- All options offer more reservoir storage than required to attenuate 2013 peak flow rate
- BRFM would like to influence operating protocols of reservoir
- BRFM looks forward to ongoing participation in phase 2
